



Dear Rec Center Ministries Teammate:

Thank you for your interest in the 10th Annual Rec Center Ministries PowerCamp (PowerCamp 2010). Rec Center Ministries is a non-profit ministry whose purpose is to foster and build the physical, spiritual, and emotional strength of youth through a program oriented ministry that provides youth with positive opportunities. This day camp will be held from July 12-15, 2010, at the Pleasant Valley School in Mullica Hill, New Jersey. The camp is for children just completing grades 3 through 7 and will offer sports clinics this year for soccer, basketball, and flag football. Additionally, an Arts & Crafts clinic will also be held during the clinic time. Each day campers will be dropped off between 8:30 a.m. to 9:00 a.m. and then picked up at 3:30 p.m. On Thursday night, a special evening session will be held to conclude the camp.

The most vital part of our camp are the Team Leaders. These individuals have direct access to the children; and therefore, have the greatest impact on their lives. It is the team leaders that demonstrate through their actions the grace of Jesus Christ! As a team leader, you will be responsible for a group of either 8-10 boys or girls of the same age group. You will be responsible for being with them all day through the morning assembly, clinics, team session (group Bible study), lunch, athletic competition, and afternoon assembly. You will impact the children!

*This year, Rec Center Ministries will be paying a \$100 stipend to the **primary** Team Leaders . In order to receive this stipend, these leaders are required to attend a Leadership Training Clinic from 10:30 a.m. on July 10, 2010 through 11 a.m. on July 11, 2010 including the overnight stay. All meals and lodging will be provided. Additionally, these team leaders will be required to be at PowerCamp each day from 8 a.m. to 4 p.m. and again on July 15, 2009 from 5:45 p.m. until 8 p.m. and meet all other expectations as listed. You may also apply to be an **assistant team leader** helping a primary leader. These positions are for those less experienced individuals and do not receive the stipend. **All team leaders are strongly encouraged to attend the Leadership Training Clinic.** Lodging and meals will be provided for any team leader traveling to volunteer at camp.*

As a prospective team leader, it is required that you fill in an application and recommendation form. This year's process will be highly competitive and we are seeking leaders that are well disciplined, enthusiastic and of all ages. The recommendation form can either be mailed with your application or mailed separately. The deadline for us to receive applications and recommendation forms is June 18, 2010. Once you are approved by Rec Center Ministries to serve, further information will be sent to you, including the Bible studies that you will lead. Any person who has the desire to share Christ with children can serve as a team leader. We are not looking for the best athletes, but the best servants!

This camp is always organized and run by an all-volunteer staff. Please help us by encouraging others to serve as team leaders and staff. Please feel free to duplicate this material and provide it to those interested. We still need volunteers to serve as team leaders, coaches, and much more. If you want to serve, we would love to have your help! Being a team leader is a great experience – thank you for influencing these children!

TEAM LEADER JOB DESCRIPTION and EXPECTATIONS

As a Team Leader, you will serve under the leadership of the Camp Director and will be trained and supervised by the Team Leader Coordinator.

Your responsibilities will include:

1. Participate in the entire pre-camp and daily training times. (Leadership Training Clinic is scheduled from 10:30 a.m., July 10 through 11 a.m. on July 11, 2010 including the overnight stay.)
2. Be at camp each day from 8:00 a.m. until 4:00 pm and again on July 15 from 5:45 p.m. until 8 p.m.
3. Be an enthusiastic example of Jesus Christ.
4. Monitor your team's needs.
 - Be responsible for team members at all times.
 - Keep team on schedule.
 - Maintain group and individual discipline.
 - Eat meals with your team and spend all time with team
 - Be available to counsel team members if necessary and refer individuals with counseling needs to the appropriate staff persons.
5. Lead Team Meetings (Bible study sessions).
 - Guide discussion involving all team members using the assigned material.
 - Come prepared to Leadership Training Clinic to discuss Bible study material
 - Lead prayer time.
6. Participate in Clinics/Competition.
 - Serve as a coach/instructor as directed by the head clinician.
 - Be a Christ-like example during competition.
7. Function within all Rec Center Ministries' policies and staff guidelines.

Rec Center Ministries' Youth Protection Policy

BEHAVIOR POLICY: Any abuse (whether sexual, physical, emotional or neglect) of the campers or fellow Team Leaders will not be tolerated. Abusive conduct or allegation will lead to immediate removal from camp leadership and responsibilities. To assist and protect your integrity and leadership responsibilities, we ask that you . . .

- ... not put yourself in a compromising situation.
- ... not rely on your good reputation or put yourself in a position where it's your word against another individual's.
- ... be aware of what you say.
- ... watch what you do, being cautious of and avoiding "bad" touch with campers and other staff.
- ... be aware that athletic activities could be opportunities for an abusive situation.
- ... focus on the spiritual guidelines while working with youth

REPORTING POLICIES AND PROCEDURES:

- Any abusive situations you observe or become aware of must be reported immediately to the staff person in charge.
- Stabilize the immediate abusive situation by stopping the abuse.
